Tax Law Update: Beginning with 2018 returns, claiming dependents no longer gets you a personal exemption for them, as the personal exemption has been eliminated in favor of a much higher standard deduction. For 2017 returns, the personal exemption was worth \$4,050 for each person on your return, which reduced your taxable income.
